# **Privacy notice**

If you choose to respond to this consultation process relating to the draft updated threat abatement plan for predation by feral cats, we will collect personal information about you. Please review this notice before submitting your response.

We are bound by the Australian Privacy Principles in Schedule 1 of the <u>Privacy Act 1988</u> (Cth). The Privacy Act regulates how we may collect, use, disclose and store personal information. We also hold personal information in accordance with the <u>Archives Act 1983</u> (Cth).

# What personal information will be collected

Personal information means information or an opinion about an individual, or an individual who is reasonably identifiable, whether or not it is true or recorded in material form.

Sensitive information is a subset of personal information and attracts a higher level of privacy protection. Sensitive information includes information or opinions about an individual's racial or ethnic origin (e.g. indigeneity), a political opinion or association, religious beliefs or affiliations, trade or professional associations and memberships, a criminal record and health information.

By submitting a response to this consultation relating to the draft updated threat abatement plan for predation by feral cats, you consent to the department collecting your personal information and sensitive information provided in your response. This may include:

- your name, location, email and telephone number.
- your views about the draft updated threat abatement plan for predation by feral cats, and its supporting background document, and how the proposed threat abatement plan may impact you.
- if you are responding on behalf of an organisation, the name of that organisation and your position in the organisation.

### How we will use and disclose your personal information

The department will use any personal information provided in your submission to:

- identify relevant stakeholders and their organisations.
- assess stakeholders' views on the draft updated threat abatement plan for predation by feral cats, and its supporting background document.
- assess the potential use and impact of the draft updated threat abatement plan for predation by feral cats.
- contact you about your submission, including for further information, feedback or to conduct a survey either by us or our representative.

• inform you about the outcomes of this consultation process and/or other matters that we consider may be relevant to you.

The personal information provided in your submission may be disclosed to department staff, staff from other government departments, Ministers and their staff, persons (including contractors) assisting the Minister on related work, Members of Parliament and their staff, and the Threatened Species Scientific Committee, for the purpose of:

- informing edits and amendments to the draft updated threat abatement plan for predation by feral cats
- informing future policy
- and for related purposes.

We may also disclose your personal information where authorised or required by law.

#### **Public disclosure**

We may publish parts of your submission in the consultation summary and other material supporting the threat abatement plan, including on the department's website (e.g. unattributed quotes or excerpts), unless you expressly ask us no to. This includes any personal or business information contained in it. Published submissions will be accessible online and by overseas recipients.

### **Anonymous submissions**

You can provide an anonymous submission. However, this means we cannot contact you about your submission, the consultation process, or other matters relevant to you. It may also limit our ability to take your submission into account.

#### Personal information of other individuals

If you are making a submission on behalf of another person, or your submission contains someone else's personal information, you must have their consent. If you do not have consent, please deidentify or remove the personal information before lodging your submission.
